Consult Financial Information:

The client agrees to pay \$1400 per month so that we can ensure the full payment of the patient responsibility fee of \$8400 in 36 weeks.

Addice Incentive Discount: If The Addice is the right choice for you, please let us know within ten days of today's consult. We will discount the \$300 from the cost. In addition, we offer a \$200 discount if paid in full at your 20-week appointment.

Discounts Available:

Addice Incentive Discount will be set up as 7 Auto Draft Monthly Payments:

\$8100 Total Cost: \$1350 per month (starting the month of your NOB)

OR

Payment in Full and Addice Incentive Discount is \$7900 Total Cost:

NOB (typically around 12 weeks of pregnancy): \$375 Due

16 Week Appointment: \$275 Due

20 Week Appointment: \$7250

Extra possible Services not included in the Addice Care Package:

Fetal Anatomy Scan and NST are included. All other scans are \$100.

Rhogram: \$105 & MTHFR: \$92

BPP (if needed at 41 weeks & 3 days): \$100

If you live within a 15-mile radius of the Addice, a midwife will visit your home within 72 hours after delivery for a visit. Otherwise, the visit will be held at The Addice.

A refund of \$750 will be issued if you are not admitted to The Addice for labor for medical reasons, and before labor begins, you are transferred to a new care provider who is not an employee of The Addice. The Addice will prorate care if a transfer of care is needed before 34 weeks of pregnancy.

Insurance Reimbursement Information:

At The Addice, we want to serve and provide the best care in all areas, and unfortunately, insurance is very unpredictable. After handling insurance for our clients, we have found that the most significant and most successful outcome for our clients is to seek reimbursement personally from your insurance provider. After much consideration and research, this will be the most effective way to benefit and serve our clients. We want to provide the best affordable maternity care and allow our midwives to give the best possible care without the financial restraints that insurance sets as an in-network provider and/or filing on behalf of our clients. We will assist and want the greatest reimbursement for each client.

The Addice Birth Center will provide all necessary documents from itemized invoices, super-bills, clinical records, CPT Codes, Tax ID Numbers, and any relevant information that insurance requires for our clients to seek personal reimbursement from their insurance provider. Most insurance providers will require you to submit the invoices/ super-bills after delivery and not before to ensure all is coded correctly for your delivery and postpartum care and follow Global Billing Guidelines.

Please note that The Addice Birth Center is an out-of-network provider, and we can not guarantee the amount insurance will reimburse you. We are not contracted with any insurance company as an in-network provider. Even with exceptions, each insurance plan sets an allowable amount they are willing to reimburse. Please consider this, along with deductibles and coinsurance, when determining any refund. Still, please be comfortable with our patient responsibility fee amount, as this is your responsibility no matter the amount your insurance reimburses. We can not be held responsible for your insurance accepting or denying reimbursement requests/invoices. Please be aware that insurance does not typically reimburse at 100%.

We encourage our clients to reach out to their insurance provider to seek further information on how to submit invoices and what information is needed, whether electronically or via fax (The Addice can fax requested information on behalf of our clients). Please inform your insurance provider that you will pay for services and seek personal maternity coverage reimbursement. Please ask and note any information provided and get a reference number when you call.

The risk is low, but if you need to be transferred to the hospital, please remember that this will add extra fees separate from The Addice, and the hospital will bill you directly for these. The hospital would likely file those claims in-network, and you would need to meet your in-network deductible before insurance starts covering your claims.
